## ■ Introduction

This form allows you to request BNP Paribas, as the manager of the “.bnpparibas” TLD, to disclose registration data related to a domain name registered under restricted access in “.bnpparibas”.

The BNP Paribas registry will acknowledge receipt of your request within two (2) working days from the date of receipt of this duly completed form by you.

The BNP Paribas registry will respond to you, unless exceptional circumstances arise, no later than thirty (30) calendar days after acknowledging receipt of your request.

The BNP Paribas registry will analyse your request considering the legal basis on which your request is founded, the reasons provided, and the supporting documents submitted in French or English. For example, disclosure of registration data may be obtained in cases of identical or nearly identical reproduction of a registered trademark, prior distinctive sign (business name, company name, trade name, sign, domain name), or even a surname or pseudonym, or the name of a local authority. BNP Paribas' analysis will focus on the similarity of the signs and will not address the content of the websites. In case of refusal, it will be your responsibility to resort to other procedures provided for by the “.bnpparibas” registration policy.

Applicant's commitments: If the BNP Paribas registry approves your request, the data that will be transmitted to you is, for some, personal data within the meaning of the legal framework related to the protection of personal data. As such, they will be transmitted to you on a strictly confidential basis and exclusively for the purposes relating to the rights and the legal basis justified in this request.

You agree to:

- Ensure that this request is made in good faith.
- Process the data received in response to the request lawfully.
- Not use this data for purposes other than those specified in this form (and/or any annexes).
- Maintain the confidentiality of the data transmitted and not disclose it to third parties except to duly authorized persons and, about personal data, only to third parties residing in countries offering an adequate level of personal data protection.

When the BNP Paribas registry responds to your request, the registration data related to the holder of the domain name in question will be sent to you by email, which is itself protected by the confidentiality of correspondence. The information transmitted by the BNP Paribas registry corresponds to the information entered by the registrar at the time of the application for registration of the domain name in question. The applicant also undertakes not to seek liability from the BNP Paribas registry regarding the data transmitted.

6. Information on the processing of your personal data and the exercise of your personal rights information that must be provided is marked with an asterisk.  
If the information marked with an asterisk is not provided, your request will not be processed.

The information collected is subject to computer processing by the BNP Paribas registry, the data controller, to enable them to analyze the request for disclosure of personal data submitted to them in accordance with the registration policy for domain names registered under “.bnpparibas” and to generate statistics. This processing of personal data is necessary for the execution of the contract entered into via this form.

The data recipients are the authorized departments of the BNP Paribas registry.

Your identification data, as well as any communications and documents related to the processing of your request, are destroyed six months from the last communication. You have personal rights, namely the rights of access, opposition, rectification and deletion of data, the right to limit processing, the right to lodge a complaint with a supervisory authority as well as the right to define directives related to the retention, deletion and communication of your personal data in the event of death; your personal rights are exercised by contacting the legal department of the BNP Paribas registry at [i\\_names@bnpparibas.com](mailto:i_names@bnpparibas.com).
